## Official Rules of the Fluidra International Pool Pro Day Residential Builder Contest

**NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE  
DOES NOT IMPROVE YOUR CHANCE OF WINNING.**

- 1. ELIGIBILITY:** The Fluidra International Pool Pro Day Residential Builder Contest (the “Contest”) is open to any active pool builders within the United States or District of Columbia, who lives in the fifty (50) United States or the District of Columbia and who is eighteen (18) years or older as of **May 28, 2024**. Employees of Zodiac Pool Systems LLC, any of its parents, subsidiaries, affiliates, advertising and promotion agencies and their family/household members (“household members” includes, parent, spouse, children, and/or siblings), or of any company affiliated with the Contest and collectively with the foregoing person or entities, are not eligible to enter. Each entrant unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of Sponsor (as defined in Section 3 below) which shall be final in all respects. This Contest shall be void outside the fifty (50) United States and the District of Columbia and anywhere else it is prohibited, taxed, or restricted by law. - 2. START/END DATES:** The Contest begins at 11:00 am. PST on **May 28, 2024** and ends at 11:59 p.m. PST on **September 9, 2024**. The submission phase of the Contest will be from **May 28, 2024 – August 16, 2024** and the final voting phase of the Contest will be from **July 1, 2024 – September 5, 2024** at 11:59 p.m.
- 3. SPONSOR:** The Contest is sponsored by Zodiac Pool Systems LLC (the “Sponsor”).
- 4. HOW TO ENTER:** The participant may enter the Contest by uploading a photo or video of their Jandy Versa Plumb equipment systems to Facebook or Instagram. Participants must tag Jandy on Instagram or Fluidra North America Facebook **and** tag PoolPro Magazine on Facebook or Instagram, include the name of their company **and** use the hashtags #BuiltJandyStrong AND #VersaPlumb. Participants may upload their entries **between May 28, 2024 – August 16, 2024**. Participants’ accounts must be public for Sponsor to see the entry. Unlimited entries per participant will be accepted. All entries become exclusive property of Sponsor and will not be acknowledged or returned. Any use of robotic, automatic, or programmed entry methods, or any entry method which is similar, will void all entries made by the company. Proof of submission will not be deemed to be proof of receipt by Sponsor.

### STRUCTURE:

### RULES:

- To enter, participants must upload a photo or video of their Jandy Versa Plumb equipment systems to their Facebook or Instagram pages. Participants must tag Jandy on Instagram or Fluidra North America Facebook **and** tag PoolPro Magazine on Facebook or Instagram **and** use the hashtags #BuiltJandyStrong AND #VersaPlumb. Participants may upload their entries **between May 28, 2024 – August 16, 2024**. Participants' accounts must be public for Sponsor to see the entry. Unlimited entries per participant will be accepted.
  - The Contest is only open to current and active pool builders. Only one (1) current pool builder is eligible to receive the grand prize.
  - Entries will be accepted until the submission phase of the Contest ends on 11:59 p.m. PST August 16, 2024.
  - All submissions must be approved by our technical experts to qualify.
  - Those that get through initial internal review, will be judged based on the following criteria (bonus points for making it to the bracket voting round):
    - Creativity
      - Example: a fun transformation in a video or catchy caption
    - Education
      - Example: give an installation tip or trick
    - Personality
      - We want to see each entrant's personality shine through
  - After second internal judging, top 4 or 8 submissions of the week will go through a bracket voting so peers can vote for their favorite installation. Bracket voting will begin July 1, 2024 and end September 5, 2024.
  - Winners of weekly bracket voting will make it to the final bracket voting phase where one winner will be selected.
  - Final judging and selection of winners will be decided upon by Jandy Instagram social media followers via a bracketing system. The final judging and selection phase will take place **between August 26, 2024 – September 5, 2024 at 11:59 p.m.**
  - In the event of a tie, winner will be decided by a blind judging panel of Fluidra Pro Academy trainers based on the quality and complexity of the finalists.
  - Once the winning participant is selected, Zodiac Contest administrators will announce the Fluidra International Pool Pro Day Residential Builder Contest winner in a separate post.
  - The winning participant will be notified of their prize as listed under section 7 - Prizes.
  - We reserve the right to select an alternative winning participant if one doesn't respond via private message within 72 hours of the time the initial private message notification was delivered to the participant.
  - Prize will be delivered on or about September 9, 2024.
5. **RESPONSIBILITY:** The Sponsor is not responsible for lost, late, incomplete, damaged, destroyed, delayed, stolen, misdirected, illegible or any other inaccurate capture of entries. Entry materials that have been tampered with or altered are void. Entries cannot defame, misrepresent or contain disparaging remarks about Sponsor or any of its products, or other people, products or companies or communicate messages or images or screen

entries and delete, if required in its sole discretion. In case of dispute as to the identity of a winner, such entry will be declared made by the account or person whose email address was originally assigned by the internet service provider.

- A total of four (4) Contest posts, requesting entries, will be published on the Jandy Instagram page between May 28, 2024 – August 16, 2024, beginning with the first post on May 28, 2024.
  - The deadline for submitting photos to count as official entries is 11:59 p.m. PST August 16, 2024.
  - The final voting phase of the Contest will run from **between August 26, 2024 – September 5, 2024**, in which Zodiac Pool Systems LLC will post entries to the Jandy Instagram page where the followers will vote on entries. The voting phase will end at 11:59 p.m. on September 5, 2024.
  - The final winner, as determined by the bracketing voting unless there is a tie, will be notified privately where they will be asked to provide availability for prize delivery.
7. **PRIZES:** The Contest will provide one grand prize winner – one (1) pool builder:

      - A \$100 Visa Gift Card to use at their discretion
